### Eligibility:

Any sole proprietorship, partnership or corporation, based in Saskatchewan, who

- a) Is a Saskatchewan based business primarily engaged in the business of dismantling motor vehicles for their parts re-use and recycling,
- b) who undertakes to follow the National Code of Practice as established by the Auto Recycler's of Canada ("ARC"), and who, upon an audit by an approved ARC auditor obtains a minimum grade of compliance (2019 -currently 75% as set by ARC), is eligible for full membership. Costs of the audit are the responsibility of the auto recycler member.

To remain a member in good standing the proof of completing the audit must be completed within the first year of membership.
